This ASSUMPTION OF RISK, HOLD HARMLESS, INDEMNIFICATION, AND RELEASE AGREEMENT ("AGREEMENT") is made on behalf of the undersigned, and any guest or relative of the undersigned, including minor children or wards thereof. This AGREEMENT shall include the payment of any attorneys' fees, and shall include the reimbursement to the Club arising out of any loss, damage, or injury to the property of the undersigned, including any guest, relative, minor children, or wards thereof, from any cause whatsoever, INCLUDING PASSIVE OR ACTIVE ACTS OF NEGLIGENCE of the Club. 6. THE UNDERSIGNED RECOGNIZES AND AGREES THAT BY EXECUTING THIS ASSUMPTION OF RISK, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT, HE OR SHE IS WAIVING AND RELEASING VALUABLE LEGAL RIGHTS.
